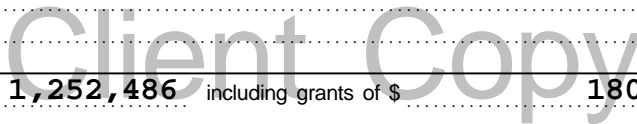

YOUTH AND FAMILY SERVICES INCLUDE THE REMAINDER OF THE ORGANIZATION'S PROGRAMS AND IN 2014 INCLUDED YOUTH DEVELOPMENT AND TEEN COURT. A FOOD PANTRY WAS OFFERED IN PARTNERSHIP WITH A LOCAL CHURCH. DURING 2014, YOUTH DEVELOPMENT OFFERED BOTH AFTER SCHOOL AND SUMMER PROGRAMMING. THERE WERE 524 YOUTH WHO WERE MEMBERS OF THE YOUTH DEVELOPMENT PROGRAM, RECEIVING MORE THAN 50,000 UNITS OF SERVICE THROUGHOUT THE YEAR. MEALS AND SNACKS WERE PROVIDED TO PARTICIPANTS DURING ALL PROGRAMS. SERVICES INCLUDE HOMEWORK HELP, STEM AND ART ACTIVITIES, AND RECREATION. A READING PROGRAM AND BASKETBALL PROGRAM ALSO IS AVAILABLE TO PARTICIPANTS. THE SUMMER INCLUDES WEEKLY FIELD TRIPS. THE FOOD PANTRY, OPERATED IN PARTNERSHIP WITH CHURCH WOMEN UNITED, SERVED 128,556 MEALS TO 17,306 INDIVIDUALS IN 2014.
